



## Take On Wall Street Campaign Summer 2024 Internship

The Take On Wall Street campaign at Americans for Financial Reform (AFR) is seeking an intern for this summer.

Take on Wall Street is a campaign supported by a coalition of over 50 national organizations — including community-based organizations, labor unions, consumer advocates, faith groups, and more — organized around moving a financial reform agenda that places economic, gender, and racial justice at the center of the fight to transform the economy and the financial system so that they work for the masses of working people, white, Black and brown.

This summer, as members of Congress continue to funnel even more wealth into the hands of rich white men, leaving millions of white, Black, and Brown working people struggling to survive in financial and economic systems that are rigged against them, the Take on Wall Street coalition is stepping up the fight to stop them. It's past time for us to build a financial system that works on behalf of working people, not against them. We are looking for an intern to join this fight for the summer. If you fit the bill, we'd love to hear from you!

### Responsibilities:

- Contribute to digital strategy and feed our social media accounts
- Help promote our message by contributing to and implementing communications, social media and outreach plans
- Track headlines and write regular and breaking news updates to coalition partners about our efforts to bring postal banking back to USPS
- Conduct research on political opportunities at the federal level with an eye towards cultivating policy champions and elevating Take On Wall Street priorities in electoral races
- Schedule and attend meetings with coalition members, policymakers, and other stakeholders
- Research and write blog posts on a range of topics
- Provide logistics support for a variety of coalition activities, including petition deliveries, stunts/actions, briefings, Congressional hearings, etc.

### Qualifications:

- Ideal candidates will have a strong commitment to racial and gender justice
- Knowledge and experience with major social platforms
- Knowledge and experience working with a website content management system, like Wordpress
- Excellent written and oral communication skills
- High proficiency with general office software (Google suite, Microsoft Word, Excel)

- We are also looking for someone who is detail oriented, has solid judgment and good relationship-building skills, and is eager to get things done

During the summer, Take on Wall Street offers a compensation of \$16.10/hour, together with stimulating, soul-satisfying work and a crash course in public-interest advocacy, racial equity, financial regulation, communications, and coalition building. Academic credit is available.

Internship is full-time for a minimum of 8 weeks. Preference will be given to applicants who can work full-time for 12 weeks. This is a great opportunity for individuals seeking to enter the nonprofit advocacy world, and expand their professional writing and research portfolio.

### **Covid Location Adjustment**

Due to COVID-19, this internship will be virtual, and meetings and orientation will take place via video. As such, candidates are expected to have access to a computer and reliable internet connection. Take on Wall Street has a well-developed internship program, enriching the experience for all the interns who work here.
